HORIZON EUROPE'S NATIONAL CONTACT POINTS CAN HELP YOU



National Contact Points (NCPs) are an EU support structure that provide **guidance**, practical **information** and **assistance** on all aspects of participation in Horizon Europe to potential applicants and beneficiaries.

NCPs offer support to all participating countries and they are also established in many non-EU and non-associated countries ("third countries") for the duration of a project and in the applicant's own language.

NCPs' core services to support your Horizon Europe application

Informing and awareness raising



Circulate documentation on Horizon Europe funding opportunities.



Organise information and promotional activities on a broad range of issues.



Strengthen the link between science and civil society and ensure gender balance.



Support activities of the Joint Research Centre (JRC), the Commission in-house science service.

Assisting, advising and training



- Assist researchers and organisations, new actors and SMEs to increase and improve their participation in Horizon Europe.
- Assist in partner searches.
- Advise on rules, administrative procedures and issues.
- Advise participants, in particular smaller organisations and SMEs, on how to set up appropriate management and legal structures.
- Explain the scope and modalities of action foreseen in Horizon Europe.
- Organise courses and training.

Signposting and cooperation

Signpost potential participants requiring assistance to other business support network services.

Support cooperation between NCPs within the network by promoting joint activities.

Provide easy access to national/regional funding services as well as European-level partnerships and collaboration among research funders.
